#### **Environment care**

The main aim of BRENTAG BULGARIA is to participate in the campaign to reduce the use of toxic products by actively promoting the use of their environmentally friendly alternatives.

In our day-to-day activities, we aim to prevent or reduce adverse environmental impacts, by storing chemicals as required, taking appropriate measures to prevent environmental accidents, using high-end, low-emission vehicles, recycled office paper, and business needs as well as wise use of natural resources.

To achieve these goals, the management and the entire team are actively involved in maintaining and improving the Quality, Food Safety, Occupational Health and Safety and Environment Management System, built in accordance with the requirements of ISO 9001:2015, ISO 14001:2015, ISO 45001:2018 and HACCP through:

- defining the context of the organization and all external and internal management issues and taking into account changes in them;
- determining and periodically reviewing all requirements regulatory, own, customer and other stakeholders' requirements related to the management system and assessing the level of their implementation / compliance;
- identifying the risks and opportunities for the business processes and environmental and occupational health and safety processes, the owners of those risks and opportunities, the criteria for assessing risks and opportunities, as well as the level of acceptable risk and planning of necessary actions depending on the risk assessment.

This policy is reviewed at least once a year when conducting management review. The management publicizes the policy among the company's employees and the persons working for the organization and encourages their contribution to its implementation. If necessary, the policy is also made available to external stakeholders.
