





Driver inspection upon deliveries

At Brenntag we value safety first, which is why we inspect unloading conditions at our customer's locations before we accept to deliver hazardous goods by road tanker.

We are now expanding these terms, which means that from now on drivers are required to fill out a checklist together with the customer before each bulk delivery or transfer from IBC to a customer tank. These terms will apply for hazardous as well as non-hazardous goods.

PREVENTION OF MISLOADS AND INCREASED SAFETY

We are implementing this new procedure in order to prevent misloads. In the future, customers are asked to sign that the hose is connected to the right tank and that the tank can hold the ordered volume before unloading is started. In addition, we will require that a representative from the customer is present during the connection and disconnection of hoses in order to help the driver if he or she should be splashed with hazardous product in case of a hose bursting or leaking couplings. We urge customers to be present not only during the connection and disconnection of hoses but throughout the entire unloading as a safety measure.

We are aware that this will demand some of your time, but will also help to prevent accidents or incidents and reduce the consequences in case of accidents.

As a part of these new terms, the driver will have to sign-off to:

- one of your employees being present
- that there is safe access to an inlet
- that the inlet is clearly marked with product name
- that there is an eye wash and emergency shower nearby (if required).

The driver is not permitted to start the unloading if these matters are not in place.

These new terms will apply for products that are loaded at Brenntag Nordic's own locations. For AdbLue and urea solutions, we will not require the presence of the customer.

We expect that this new procedure will start up during the first quarter of 2019.
