





This is a civil administrative penalty action brought against Respondent pursuant to Section 16(a) of the Toxic Substances Control Act (TSCA), 15 U.S.C. Section 2615(a), for violation of Section 15(3)(B) of TSCA, 15 U.S.C. Section 2614(3)(B), and federal regulations promulgated to implement: (1) Section 8(a) of TSCA, 15 U.S.C. Section 2607(a), at 40 C.F.R. Part 711; and (2) Section 12(b) of TSCA, 15 U.S.C. Section 2611(b), at 40 C.F.R. Part 707. Total Federal Penalty Assessed or Agreed To is \$128.265






